#### **HUB CLUB**

The BCGBA has been working closely with the Bowls Development Alliance (BDA) with an initiative to develop 'Hub Clubs', Hub Clubs will become a base for BCGBA and affiliated clubs of other bowling codes to seek help and support in the locality.

The first of these Hub Clubs is being trialled in Merseyside at Oxton Conservative Club (pictured below) with Erdington Court in the West Midlands now underway.

The idea will be to lay on seminars and (free courses or subsidised) for Clubs in the area, as well as having Ian Gill, the BDA Club and Community **Development Officer for** the Northwest, based there for Clubs to come and meet with him. Ian is working closely with Bill Dow. the Merseyside County Development Officer.



The Hub Club initiative will also explore how clubs can be better connected into their local communities and serve some of the more disadvantaged in society who may struggle to access the sport currently due to perceived barriers such as age, disability, gender or economic disadvantage.

Many clubs may be doing fine, but there is always scope for learning new things and, for those clubs that are struggling for members, there are some easy strategies that have been proven to work to help you get new members and enable your club to thrive.

Following a recent survey to clubs in the locality of the Hub Club, it became clear that the most important courses for clubs will be around 'Grants and Finance', 'Member Recruitment and Retention', 'Club Promotion and Advertising' and 'First Aid'. These will be prioritised throughout the year and will either be held online or in person.

In addition, it was slightly worrying to learn how few clubs from those who answered the survey had no website or social media presence and help will be available for clubs who wish to develop in this area. Several clubs have been assisted to start new websites to both inform their members and as a tool to attract new ones. This is not actually that difficult to do and very often there are free options, such as Wix and WordPress.

#### **CLUB HEALTH CHECKER**

The BDA is soon to be introducing an online 'Club Health Checker. All County Development Officers were invited to an online presentation last month with the aim of the Health Checker, once all sections are completed, is to provide a comprehensive report on what your club is doing well and where there are areas of improvement needed. Clubs will be notified once it is ready for them to complete.

### Safeguarding News

#### Focus on ... Safeguarding in Bowls

Safeguarding is all the processes used to keep people safe from harm, abuse and/or neglect. It involves raising public awareness so that communities, alongside professionals, understand their part in preventing, identifying, and responding to abuse and neglect. People in sports clubs and organisations can help by being aware of what constitutes abuse of children and adults at risk and by knowing what to do if they have concerns about the wellbeing of a fellow bowler or the behaviour of someone in the sport towards children or adults at risk.

#### **Working Together to Safeguard Children**

Paragraph 63 of this statutory government guidance booklet identifies the role of sports clubs and organisations in safeguarding children.

There are many sports clubs and organisations including voluntary and private sector providers that deliver a wide range of sporting activities to children. Some of these will be community amateur sports clubs, some will be charities. All should have the arrangements described in this chapter in place and should collaborate to work effectively with the safeguarding partners as required by any local safeguarding arrangements. Paid and volunteer staff need to be aware of their responsibilities for safeguarding and promoting the welfare of children, how they should respond to child protection concerns and how to make a referral to local authority children's social care or the police if necessary."

#### The Care Act 2014

This is the main piece of legislation regarding the safeguarding of Adults at Risk. Bowls clubs have many more adult members than children and so awareness of responsibilities under this law is important alongside those related to child protection. The Act defines Adults at Risk as a person who: Has care and support needs, whether or not the Local Authority is meeting any of those needs and; is experiencing, or at risk of, abuse or neglect.

#### Types of Abuse / Safeguarding Concerns

There are more types of abuse of adults identified in the main legislation than there are for children, although this is changing all the time. The 4 main types of abuse are the same for both and can be remembered using the word PENS.

- Physical abuse
- **Emotional** abuse
- Neglect
- Sexual abuse



Additional types of abuse for adults are:

- Financial / material abuse
- Discriminatory abuse
- Domestic violence/abuse
- Modern slavery
- Self neglect
- Organisational abuse

#### **Prevent Duty Update**

Protecting children and adults at risk from all types of grooming is a safeguarding responsibility. This includes the grooming activity of extremist groups who want to radicalise individuals. Counter Terrorism Policing (CTP) launched a website in November 2020 - actearly.uk - to encourage friends and family to act early, share concerns and seek help if they are worried that someone they care about is being radicalised.

#### **BOWLS' BIG WEEKEND 2022**



Bowls' Big Weekend is back for 2022 and will be held between Friday 27th and Sunday 29th May.

This is an excellent way to recruit new members to your club and those clubs that took part in the inaugural year in 2021 will reap the rewards of their efforts with increased membership for the season ahead.

#### **ANNUAL MEETING RESCHEDULED**

Due to the concerns over continuing recording of positive Covid cases, the 2022 BCGBA Annual Meeting that should have taken place on Saturday 15th January will now take place on Saturday 5th March. As usual, the morning session will be to discuss and vote upon any proposed rule changes with the afternoon session for the submission of reports and other agenda items.

In the morning Rules Revision Meeting, the only contentious issue will be the proposal to introduce a £10 annual fee for all leagues and associations. The rationale behind the proposal is that leagues and associations receive the same benefit as our clubs regarding Public Liability Insurance but do not currently pay an annual fee.

Other rule changes up for discussion are:

- To reduce the time frame that counties have to submit their teams for the Senior and Junior County Championships, from 21 days before a match to 14 days.
- To allow counties to appoint a 'home' referee in county matches, except for the semi-final and final where neutral referees will be appointed.
- To further define the 'definition of a playing member' to cover those leagues who allow players to 'guest' for a club without having to be a paying member.
- To introduce the same system for the allocation of places in the Junior Merit to match those of the Senior Merit.
- To approve a raft of proposed changes to the Laws of the Game, some of which are just a tidying up exercise.

The afternoon session will hear the annual reports of the CEO and Financial Officer and will also vote upon accepting the Federation of Crown Green Bowls as full members of the association. Probably the most important decision of the day will be the vote to allow the CEO to move forward with establishing an Independent Board to allow the association to move forward. If he is given the green light, after a period of consultation with county associations, it is hoped to have the new board in place in January 2023.
