

## CHLOE CROWNED LADIES CHAMPION



**CHLOE HIRST** (Yorkshire) denied Nicola Boulton a second successive **BCG Ladies Senior Individual Merit** title with a thrilling 21-20 final victory, to be crowned a worthy 2022 champion.

Played in the soaring heat at the excellent Brighthouse Sports Club in her native Yorkshire, Chloe came through six rounds of competition unscathed and was presented with the trophy by a proud Ladies President, Sheila Whiteley.

Chloe made her intentions known from the off, opening with a resounding 21-5 success over Anita Richardson (Merseyside) on Green 1 but had to dig deep in her second round match with Elaine Jones on Green 2. With Elaine making the better start with leads of 13-7 and 18-11, Chloe got a hold of the jack with a welcome double and then ran out to game. Back on Green 1, she was again in tremendous form to book her place in the quarter-finals with a 21-6 defeat over Sue Gawne (Isle of Man).

Nicola Boulton (Mid Cheshire), the winner in 2019, restricted her first three opponents to just 24 chinks between them. She began on Green 2 with a convincing 21-9 victory over Lynsey Gorman (Merseyside), switched to Green 1 where she inflicted the same score on Jane Cooper (Staffordshire) and then back on Green 2 she booked her place in the last eight with 21-6 defeat over Clair Russell (North Lancs & Fylde).

The last eight were all played on Green 1 with both finalists having tough games. Chloe once again had to dig deep to

run out on Catherine Lockwood (North Lancs & Fylde) coming from 20-16 down while Nicola, having trailed 9 nil to Vikki Wilson (South Staffordshire), progressed to the penultimate stage with a 21-18 success. And it was a similar story in her semi-final match with Louise Ollerton (Greater Manchester). Louise had eight on the card before Nicola could get going, eventually winning 21-19. Meanwhile, Chloe was always in control of her match with Shannon Kernick (Warwick & Worcester) with leads of 8-0, 13-4 and 15-9. Shannon fought back to get within two of Chloe at 14-16 but could not maintain her momentum and suffered a 21-14 defeat.

The final was a tremendous affair with nothing separating the ladies in the early exchanges. From 11 across, Chloe pulled away to lead 14-11 and 19-15 only to see Nicola use all her experience to require one chink for the game at 20-19. Chloe took advantage of a poor lead from Nicola and when she was unable to improve with her second bowl Chloe sent her final bowl to secure victory.

## MEN'S COUNTY CHAMPIONSHIP REACHES PENULTIMATE STAGE

Lancashire, Shropshire, Warwick & Worcester and Yorkshire will do battle on Sunday 7th August in the semi-finals of the **2022 BCGBA Endsleigh Senior County Championship**, vying for a place in the September final and the chance to lift the coveted Crosfield Cup.

**Warwick & Worcester** secured their semi-final place with a 119 chalk decimation of Staffordshire in their final Section 1 match, topping the group with maximum points.

Arch-rivals, **Yorkshire**, who they lost out to in last year's County Championship Knockout Trophy final, stand in their way of a place in the final after their victory over Greater Manchester in Section 2. Through their superior aggregate, the White Rose County were almost guaranteed a semi-final spot regardless of the outcome of their final match but Greater Manchester matched them all the way, just missing out on victory by four chinks overall.

**Shropshire** came through Section 3 with an unblemished record, closing with a resounding 80 chalk victory over Cumbria. They now play **Lancashire** who qualified for the semi-finals without playing. They were in the three-team Section 4 and were hoping Wales wouldn't win their final fixture with North Midlands by 18 chinks or more. As it was, North Midlands won by 49 chinks leaving all three teams level on two points each. Lancashire's superior aggregate saw them through.

## AMBER WARNING DELAYS LADIES COUNTY CHAMPIONSHIP DECIDERS

Following a number of concerns raised by counties following the Amber Warning issued for Extreme Heat on Sunday 17th July, the decision was taken to allow counties to postpone their matches as they had a duty of care to their bowlers, some of whom are advanced in age.

Out of the nine matches scheduled to play, four took place which has resulted in three teams confirming their place in the semi-finals.

**Wales** have booked their place in the last four following a narrow four-chalk victory over Greater Manchester in Section 1 but must wait for Section 2 to be decided.

**Yorkshire** are in prime position as their plus aggregate of 338 and two point advantage must surely see them through.

The other semi-final will be between **Shropshire** and defending champions, **Warwick & Worcester**. Both sides won comfortably in their final round of matches, Shropshire by 91 over North Derbyshire in Section 3 while Warwick & Worcester defeated North Warwickshire in Section 4 by 66.

Following a rule change at the 2019 Annual Meeting, counties finishing second in Sections 1 to 4 will contest the Mavis Dearden Supplementary County Championship semi-finals. North Midlands (Section 3) will play North Warwickshire (Section 4) but the other semi-finalists won't be known until the outstanding matches have been played.

## JUNIOR TITLES DECIDED

As expected, Yorkshire claimed a sixth consecutive **BCGBA Junior County Championship** title as they finished off their season with a resounding 140 chalk victory over Staffordshire. Who finished runners-up was dependent on the outcome of the Shropshire versus Wales fixture with both sides level on points going into this final fixture though Wales had a far superior aggregate difference.

In Shropshire, at St Georges BC, Jess Lacey's 21-8 card ensured Wales came away with a narrow 7 chalk victory but a 14 chalk loss at Caernarfon BC would see Shropshire secure the runners-up spot with seven chinks to spare. Wayd Pawlowski and Camilla Parsonage both handing in 21-4 cards for the Salopians.

In the **BCGBA Junior Six-A-Side Team Championship**, Warwick & Worcester (Pictured) and Cheshire were the winners of their respective group finals played at Heaton Park and St Mary's Park in Greater Manchester.

Group A was played at Heaton Park where the top two teams from the four groups played in May were drawn into two



further Sections with the section winners playing off. Warwick & Worcester 'A' proved too strong for South Yorkshire, winning by 23 chinks overall in the final.

Group B was played at St Mary's Park where the top two/three teams from the May fixtures were again drawn into two further sections. In a similar scenario, Cheshire 'A' ran out winners by 25 chinks against North Midlands 'B'.

## CHANGE OF VENUES FOR JUNIOR MERIT / 18-25 OPEN CHAMPIONSHIP

Counties have until Sunday 31st July to submit their entries for the 2022 BCGBA Junior Individual Merit and for the new competition specifically for the 18 to 25-year age group.

This year's **Junior Merit** will now be played at Ashton Cricket Club (Rayner Lane, off Lord Sheldon Way, Ashton-under-Lyne OL7 0FU) as the original venue of Royton Cricket, Bowling & Tennis is unable to host the event. Each of the sixteen counties will have two representatives in the 32-strong line-up on Saturday 20th August. The full draw

should be available on the BCGBA website from Wednesday 3rd August.

The inaugural **18-25 Open Championship** was scheduled for Heaton Park on Sunday 14th August but as they are now not able to host the competition, play will move to Windle Bowling Club (Hard Lane, St Helens WA10 6JT). Each of the sixteen counties will have four representatives in the 64-strong line-up and the full draw should be available on the BCGBA website from Wednesday 3rd August.

Pessall (Shropshire) bowed out in the first round, 21-20 to North Lancs & Fylde's Trevor Bibby while Merry (Cheshire) lost out to Melvin in the semi-finals, 21-16

Proctor's day started with a 21-8 opening victory over John Bonatti (Wales) and followed that with a 21-12 success at the expense of Paul Walton (Derbyshire). His quarter-final encounter with Robert Wiltshire (South Yorkshire) saw him get over the line with four chinks to spare (21-17) and was pushed even harder by Warwick & Worcester's Ronnie Regan in his semi-final, winning a close game 21-18.

Meanwhile, Mark Melvin had a tougher route on his way to the final. He started with a First Round success over Mark



Thomas (Shropshire), 21-16, then defeated Lancashire's Duncan Watkins 21-14. Two 21-16 victories saw him progress to the final with John Mountford (Potteries & District) losing out in the quarter-finals and former winner, Gerald Merry, in the semi-finals.

Andy's victory has earned him a place in the BCGBA Champion of Champions and BCGBA President, Ken Howarth presented him with his prize money and trophy.

## VETERANS COUNTY CHAMPIONSHIP REACHES ITS FINAL STAGE

Qualifying is complete in the **2022 BCGBA Veterans County Championship** with the four regional qualifiers now known after a long day bowling on fast tricky greens in hot conditions.

**Merseyside** came through Region 1 at Bamber Bridge Catholic Club (North Lancs & Fylde) with their 100% record intact following victories over Lancashire (4), Cumbria (3) and hosts North Lancs & Fylde (21). They will play **North Derbyshire Parks** in their opening match on finals day after they topped Region 2 as hosts on Staveley King George V BC. They were tied on points with South Yorkshire but their better aggregate saw them through.

Defending champions, **Potteries & District**, were drawn in Region 3 at Esclusham BC, Wales, and faced two former winners, hosts Wales, and Cheshire, in the defence of their

title. They dominated their round-robin matches from the off, starting with a 33 chalk victory over Greater Manchester and ending the hopes of the former winners, Cheshire (9) and Wales (36), from progressing to another finals day. Their first opponents on finals day will be **Shropshire** who were rarely troubled in their three matches at West Bromwich Football Supporters Club, hosted by Warwick & Worcester, securing victories over Staffordshire (28), Warwick & Worcester (27) and North Midlands (15).

The final four counties will now play again on a round-robin basis to determine the 2022 champion at Owley Wood Recreation Club (Barrymore Road, Weaverham, Northwich CW8 3LS). The finals take place on Thursday 4th August, 10am, and you will be able to follow the live scores via the BCGBA website.
