The Derbyshire bowler restricted his first two opponents, Sam Bennett (Wales) and Jordan Millman (Shropshire) to just five chalks each as he eased his way to the quarter-finals.

Here, it was looking like his day was about to end as he trailed Mia Benton from the host county 18-6. A 10-break got him to within two of his opponent but he lost the jack at the next end to leave him just two chalks from defeat. He regained his composure to finish with a run of singles and a relieved 21-19 winner.

He was back to his best in his semi-final against Alfie Knight (North Midlands), winning 21-9 and claiming the junior title at the expense of Owen Evans from Staffordshire, 21-14 in the final.

BCGBA Deputy President, Frank James, made the presentation of the magnificent trophy to Louie whose victory earned him a place in the 2023 BCGBA Champion of Champions.

## STAFFORDSHIRE AND SHROPSHIRE CLAIM COUNTY TITLES

The county championship season drew to a close for another year when Shropshire inflicted a heavy overall 64-chalk victory over Warwick & Worcester in the final of the **2023 BCGBA Ladies County Championship**.

Shropshire were determined that they weren't going to end up bridesmaids again after last season's 73-chalk loss to Yorkshire and opened up an 81-chalk advantage by the halfway stage, restricting the former winners to just two winning jacks, one at each venue.

Warwick & Worcester fought hard on their Ye Olde Knowle No 1 green, turning a 45-chalk deficit at the halfway stage into a 12-chalk victory, thanks to their last four players. Shannon Kernick won 21-8, Joan Ingram and Kirsty Darling both won 21-9 and Emily Kernick 21-10. Sian Skelton's had got Shropshire off to a great start, winning 21-5.

On their Hanwood green, Shropshire got better as the game went on. After Natalia Connor's opening 21-7 win, Shavorne Osbourne added a 21-7 card with Cheryl Caswell rounding proceedings off with a 21-8 card and a 76-chalk victory with the visitors only claiming two winning jacks.

In the **Mavis Dearden Supplementary County Championship** final, South Yorkshire kept a firm grip on the title they won last season following another tough match, this time against Burton & District. North Warwickshire fell 13 chinks short last season while Burton & District got within 9 chinks of the defending champions.

South Yorkshire won by 22 on their Whiteley Woods green with Jayne Kent (21-3) and Lisa Brownell (21-8) the best of their seven winners. Over on Stretton Bowls, Debbie Talbot (21-6) and Kellie Boyd (21-7) were their standout cards.

Attention now turns to season 2024. The counties finishing bottom of the section this season automatically transfer to the Presidents Section next season. The four teams in this season's Presidents Section – Mid Cheshire, Cumbria, North Derbyshire and Merseyside – are integrated into the sections where the bottom sides would have played in 2024.

In the Men's **2023 BCGBA Senior County Championship** final, Staffordshire's twenty-seven-year wait to win the coveted Crosfield Cup is over as they secured a 37-chalk overall victory over Derbyshire.

They suffered a 45-chalk defeat on Derbyshire's Stretton Bowls Club green where Nathan Dawes opening 21-8 card was the best of their four winners. John Dewy (21-4) and Darren Carter (21-8) were the stand-out cards for the home side.

At home, they used Stafford Bowling Club to their full advantage, claiming the first nine jacks in an 82-chalk success. They had opened up a 44-chalk advantage after the first four jacks with Dan Bodley and Chris Ward winning 21-6 and Scott Simpson winning 21-9. Glynn Storer (21-5) and Kevin Hucknull (21-8) were impressive winners in the middle four jacks.

Like the ladies, attention now turns to 2024 and the possibility of Staffordshire and Derbyshire meeting in the final again is plausible as they have been drawn in separate groups and in separate halves of the draw.
